Minimum Qualifications, Pay Scales and Other Conditions:

1. A) Master's Degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) in concerned / relevant / allied subject from Indian University or an equivalent degree from an accredited Foreign University.

A relaxation of 5 % shall be allowed at Bachelor's as well as at Master's Level for the candidates belonging to,

Scheduled Caste / Scheduled Tribe / Other Backward Classes (OBC) (Non Creamy Layer) / Differently-abled a] Blindness and low vision b] Deaf and Hard of Hearing c] Locomotors disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy d] Autism, intellectual disability, specific learning disability and mental illness e] Multiple disabilities from amongst person under a] to d] including deaf -blindness for the purpose of eligibility and for assessing academic record during direct recruitment. The eligibility of 55% marks (or an equivalent grading system in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace marks procedure.

Relaxation of 5% is applicable (from 55% to 50% of the marks) to the Ph.D. Degree holders, who have obtained their Master's Degree prior to 19th September 1991.

B) Having passed National Eligibility Test (NET) **OR** State Eligibility Test (SET) OR having been awarded Ph.D. degree in accordance with the University Grant Commission (Minimum Standards and Procedure for Award of M.Phil. / Ph.D. Degree Regulations 2009 / Regulations 2016 and their subsequent amendments from time to time as the case may be).

OR the Ph.D. degree been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the Quaequarelli Symonds (QS)/the Time Higher Education (THE)/the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai)
